Motion by Pat Lach to accept the November HOA board meeting minutes and the Annual Meeting minutes, seconded by Karla Marzineck.

Financials:

Board reviewed proposed budgets and discussed options for dues increases. Linda put forward a motion to not increase the dues for 2025; Kelly Jones seconded. Board members present voted their agreement. The board will complete a reserve analysis in winter 2025 to determine the need and timing for future increases.

Randy will sign the contract with Landscape East & West to install 1-1/2 inches of bark dust in all of the Lea Terra Park plant areas with the intention of the work being completed in March 2025, for \$13,290. (They will honor the price even if there's an increase in the spring.)

New Business

The HOA President and Treasurer have opted not to comply with the Corporate Transparency Act and the HOA will not file with the Financial Crimes Enforcement Network (FinCEN) under the CTA's reporting requirements until the resolution of a a preliminary injunction issued by the U.S. District Court for the Eastern District of Texas in the case of Texas Top Cop Shop, Inc., et al. v. Garland, et al., which temporarily blocks the enforcement of the CTA's beneficial ownership information (BOI) reporting requirements by the U.S. Department of Treasury.

The board has agreed to go forward with Scott's suggested plan for implementing Google Workspace instead of Microsoft 365.

The next LTP board meeting will be held Tuesday, January 21st, 2024, at Randy's house. The meeting was adjourned by 7:30 pm.
